## **April 8 Morning events:**

Party business.

- Introductory remarks from Julie Saporito-Acuna, Chair.
- Elections Committee Chair Aaron Hyndman invited each county liaison to introduce their candidates, then took a photo of all the 2017 candidates.
- Communications Committee Vice-Chair Laura Genna reported on plans and organization for the committee and encouraged each local to make sure at least one member joins.
- Membership Committee Chair Brian Powers reported on the committee's success in organizing nine local affiliates (Monmouth, Ocean, Bergen, Atlantic, Camden, Gloucester, Union, Warren/Morris/Sussex, Essex) during the past year.

# **April 8 Afternoon events:**

Aaron Hyndman, Elections Chair, facilitated the voting on bylaws amendments.

- Bylaw amendment 1 part 1 replace Chair and two Vice Chairs with three Co-Chairs
  - After caucusing, each side had 2 speakers speak for one minute each: Al Clayton and Mike Mangels spoke For, Gary Frazier and Gerald Martin spoke Against.
  - o Quorum count: two-thirds of registered Greens present is 42.
  - Hand vote counted by Daily Millard (designated by Aaron Hyndman as parliamentarian).
  - The motion passed with more than 42 votes in favor.
- Bylaw amendment 1 part 2 diversity conditions on the three Co-Chairs
  - After caucusing made it clear that the Against side was much larger, the For side decided to decline the opportunity to speak and agreed to go directly to a voice vote.
  - The motion failed.

Brian Powers, Membership, facilitated the voting for GPNJ officers.

- Co-Chair elections (Bylaw amendment 1 stated that if passed, it would take effect immediately, not on June 1)
  - o Brian explained the rules for voting when a position was contested.

- Co-chair candidates nominated were: Gary Frazier, Heather Warburton, Mike Mangels, & Aaron Hydman. Each candidate spoke about their qualifications.
- Voting was conducted by paper ballot. Brian read out each vote and it was tallied on a flip chart.
- Winners were: Heather, Aaron, & Mike.
